Background

Solano County's Facilities Management division, led by Facilities Manager Jason Alvarez, oversees approximately 55 buildings, with grounds spread across seven cities. The facilities team manages properties ranging from major facilities in Fairfield, Vacaville, and Vallejo to smaller venues like veterans' halls and touchdown spaces in other cities.

With an impressive 91% completion rate on work orders, Solano County was asking themselves what else they could be doing with Brightly Software to make their county more efficient.
